Bylaws Revision and Schedule News from Jill Lundquist, LLI Council 2nd Vice-President

Throughout the 2016-17 school year, the Bylaws committee, which I led as one of my responsibilities as 2nd vice president, thoroughly reviewed our bylaws in the light of LLI's current needs. Our ideas were then reviewed with the Executive Committee and the Planning and Evaluation Committee. The proposed revisions to the Bylaws were approved unanimously by the LLI Council in June. The entire LLI membership then voted to approve the new bylaws in July, and the results were reported to the membership at the September Annual Meeting.

As a result, the LLI annual calendar and committee structure will change:

- The Annual Meeting will move from September to May. That change brings our
 operational year and our annual budget into line with Bard's fiscal year, which runs from
 July 1 June 30. Previously, we operated without a budget approved by the LLI
 membership from July 1 to September each year.
- Elected officers and members at large will serve terms from July 1 June 30, rather than September September.
- The number of LLI committees is reduced from 8 standing and 9 ad hoc to 6 standing committees that are broader in scope, with each an "umbrella" for several LLI functions. The committees will be more interdisciplinary to encourage collaborative work and communication.

Here's what to expect. The Annual Meeting will be held Friday, May 18th, in Olin Hall Auditorium. We chose a large meeting space to allow all members to attend. Food will be provided and there will be an opportunity for socializing between 9 and 10 a.m. The business meeting will be held from 10-11 a.m. This will be followed by an entertainment program, which Gene Burns is developing. We will not have a spring luncheon.

In January, there will be a call for nominations for open Council member positions; we will be electing the President, 1^{st} Vice-President, Treasurer and two Members at Large. E-voting is scheduled for March 16-30, with results to be certified to the LLI Council for approval on April 16. The results will then be reported to the membership at the Annual Meeting in May. Finally, the Planning and Evaluation Committee is working throughout this school year on a plan to implement the new committee structure.

I believe these changes will help strengthen LLI and move us forward.
